

New Owners and Registered Tenants can sign and pick up their pool tags in the office during office hours. *No one will be allowed admittance to the pool without a pool tag. Lost pool tags cost \$5.00 for replacement.*

Guest swimming in the pool requires a visitor's pass. Visitor's passes must be acquired by the Owner of the property. Owners are allowed no more than two passes at a time; passes are available only from the YCC #41 Office during normal office hours.

Please familiarize yourself with the all Pool Rules and Regulations. Pool Rules and Regulations are posted in the bulletin board by the elevators.

To ensure that children and Adults have a safe and enjoyable swimming experience, please read the below

Facility Swim Test

- Individuals must demonstrate comfort in water and be able to swim a minimum of 2 widths continuously in shallow water.
- If you wish to take pictures of your child while they are swimming, please speak with the lifeguard on duty.

Swimming attire

• Swimmers must change from street clothes to a swim suit and/or clean clothing that permit the individuals to swim safely in the pool.

- Owners must be reminded that they are entirely responsible for their child(ren)/ guest. They must effectively supervise them at all times.
- Child(ren)10 years and younger must be must be accompanied by a parent, guardian or designate (caregiver) who is at least 14 years of age and is responsible for their direct supervision. Caregiver must be in bathing attire and within arm's reach of the child(ren) at all times, both in and out of the water
- A maximum of four bathers to one parent or guardian (4:1) for non-swimmers. The maximum increases to eight bathers to one parent or guardian (8:1) if lifejackets are worn by all non-swimmers in their charge.

***** Booking the Elevator during Carpet Project

If you require an elevator for a delivery or moving in or out **you must book in writing at least 72 hours in advance** with the Condominium Office and usage time will be **limited to 3 hours** as per YCC#41 Rule #44. This will allow us to schedule around the needs of the carpet contractor.

***** Fireworks

Please be reminded, fireworks are strictly prohibited on YCC #41 property. Fireworks pose a significant fire hazard and may do considerable harm to persons or property.

Fireworks are especially prohibited to be used on any balcony.

As per York Condominium No. 41 Rule & Regulation #27: No owner shall do anything or permit anything to be done that will increase the risk of fire or the rate of fire insurance on the property or any part thereof.
