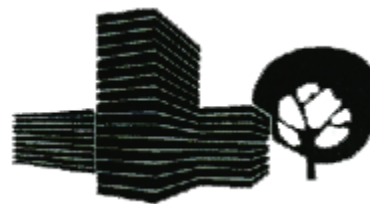


## Pool Hours of Operation

To ensure that children and adults have a safe and enjoyable swimming experience, please familiarize yourself with the all Pool Rules and Regulations.

### **Swim Tag Required:**

New Owners and Registered Tenants can sign and pick up their pool tags in the office during office hours. *No one will be allowed admittance to the pool without a pool tag. Lost pool tags cost \$5.00 for replacement. All Residents who wish to use to the pool, please pick up pool sticker to validate pool tags.*

*Please Note: No one will be allowed admittance to the pool without a validated pool tag.*

### **COVID-19 Pool Regulations**

-A maximum of 20 swimmers are permitted in the pool / on pool deck at any one time.

-Any Resident with symptoms of COVID -19 will not be permitted entry into the pool.

### **Swim Times:**

Residents will be permitted to swim in one (1) hour blocks of time (15 minutes registration, 45 minutes swim time).

-The one hour appointment times are scheduled on a first come first serve basis.

-Appointment times are at: 10:30 a.m., 11:30 a.m., 12:30 p.m., 2:30 p.m., 3:30 p.m., 5:00 p.m. & 6:00 p.m.

### **What Happens When I Arrive At The Pool?**

Step #1: Present Pool Tag At Appointment Time

When you arrive for your appointment you must present your pool tag with validated sticker to the lifeguard.

Step #2: Sign In / Questionnaire

You will be asked to sign in and complete the City of Toronto Public Health Questionnaire. Any Resident with symptoms of COVID -19 will not be permitted entry into the pool.

Step #3: Take Your Temperature

Your temperature will be taken by the lifeguard with a non-touch thermostat. Any Resident with a temperature will not be permitted entry into the pool.

Step #4: Residents approved for swimming must wait on physical distancing line, until Lifeguard returns to lifeguarding station and gives permission to enter the pool. Entry to the pool is via stairs only.

### **Physical Distancing on Pool Deck / Swimming.**

Each family is expected to physical distance at all times while on pool deck/ in the pool. Keep 2 meters (6 feet) apart from others not residing in your household. *Any Resident found in violation of the City of Toronto Public Health or York Condominium Corporation NO. 41 Pool Rules and Regulations will be asked to leave the pool deck by the lifeguard.*

### **Guest?**

There will be no guest passes issued for the pool this year.

### **Swimming Lessons?**

There will be no swimming lessons offered this year because of physical distancing regulations.

### **Swimming Attire**

- Swimmers must wear a swim suit.

### **Child to Adult Safety Swim Regulations:**

- Owners must be reminded that they are entirely responsible for their child(ren). They must effectively supervise them at all times.
- Child(ren) 10 years and younger must be accompanied by a parent, guardian or designate (caregiver) who is at least 14 years of age and is responsible for their direct supervision. Caregiver must be in bathing attire and within arm's reach of the child(ren) at all times, both in and out of the water
- A maximum of four bathers to one parent or guardian (4:1) for non-swimmers. The maximum increases to eight bathers to one parent or guardian (8:1) if lifejackets are worn by all non-swimmers in their charge.
- If you wish to take pictures of your child while they are swimming, please speak with the lifeguard on duty.

### **Facility Swim Test**

- Individuals must demonstrate comfort in water and be able to swim a minimum of 2 widths continuously in shallow water to be permitted entry into the deep end of the pool.
