

An additional holiday garbage bin will be available from *December 20*, 2017 – January 3, 2018 for all residents to dispose of extra garbage items. The additional Holiday Garbage Bin will be located in the visitor's parking lot. This bin is for garbage only. Please continue to recycle and compost in the appropriate bin as usual. Large items are to be disposed of with Special Pick Up do not put in Holiday Bin.

Holiday Decorations

No natural Christmas Trees are permitted in the building (York Condominium Rule & Regulation #33). Holiday decorations are not permitted to be hung on the window sills, railings and other external parts of the unit (York Condominium Rule & Regulation #12); such decorations could cause damage to person(s) or property should they fall.

Party Room Rentals

All owners are invited to make use of the Party Room this holiday seasons. The Party Room hold up to 40 guests, and provides access form the visitor's parking lot. Tables and chairs are provided as well as access to a private kitchen / bathroom. The Party Room rental fees are \$180 /day in addition to a \$50.00 deposit. The following information must be provided in order to avoid being issued a parking violation citation. If any of the information below is missing, you will be ticketed:

ADDRESS and UNIT NUMBER of the Resident LICENSE PLATE and make of Vehicle DATE and TIME

A license plate may be called in only 10 times a month. Visitor's Parking is for Guests Only. No Residents are permitted to park in the Visitor's Parking Lot for any time (Rule #42). All vehicles parked illegally will be ticketed or towed.
